

**RESOLUTION NO. 2004-82**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AMENDING THE 2003-2004 FISCAL YEAR BUDGET TO  
ADD THE POSITION OF ADMINISTRATIVE SERVICES CLERK AND  
TO APPROPRIATE FUNDS TO PROVIDE FOR THE POSITION**

**WHEREAS**, the City Council recognizes the need for additional administrative support for utility billing services provided to the public effective July 1, 2004; and

**WHEREAS**, the City Manager recommends that the Administrative Services Clerk position be created to provide the additional support.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Elk Grove that the 2003-2004 Fiscal Year Budget be amended to add the position of Administrative Services Clerk, a non-exempt position, salary range G88; and to appropriate \$3,500 from the general fund reserve to Account No. 100-29600 and \$3,500 from Utility Billing fund 560-40000-4001 and \$3,500 from various fee district funds to provide funding for the position for the remainder of the 2003-04 fiscal year.


