**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH VALLEY
SLURRY SEAL COMPANY FOR THE SLURRY SEAL PROJECT 2004**

WHEREAS, as part of the City's annual resurfacing program, various streets throughout the City have been selected to receive slurry seal treatment; and

WHEREAS, slurry seal treatment of these streets will extend their service life;
and

WHEREAS, construction cost will be funded by Gas Tax proceeds.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager or his designee to execute a contract with Valley Slurry Seal Company for the Slurry Seal Project 2004 in the amount of \$536,505 pursuant to the call for bids previously released by the City Engineer.


