APPROVING THE PURCHASE OF A MODULAR BUILDING FOR THE CITY'S  
CORPORATION YARD WAREHOUSE**

**WHEREAS**, In order to effectively meet the City's long term space planning needs a modular building is needed for the City's Corporation Yard Warehouse; and


**WHEREAS**, The modular building will act as a fully functional stand along office building with all components of other buildings including: electrical, carpet, fire sprinklers, cubicle space, windows, doors and other typical amenities; and

**WHEREAS**, the modular building will be housed in the City's Corporation Yard Warehouse and is approximately 1,728 square feet.




