

RESOLUTION NO. 2007-30

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE TRANSFER OF 26 BUSES FROM SOUTH COAST AREA TRANSIT (SCAT) AND 13 BUSES FROM METRO REGIONAL TRANSIT AUTHORITY (METRO) TO THE CITY OF ELK GROVE, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE BILL OF SALE WITH METRO

WHEREAS, the City provides transit services within the City of Elk Grove and parts of the City of Sacramento; and

WHEREAS, the City, in an effort to improve bus reliability, has searched and identified 26 Compressed Natural Gas (CNG) buses from the South Coast Area Transit (SCAT) and 13 CNG buses from the METRO Regional Transit Authority (METRO); and

WHEREAS, SCAT, METRO and the City have negotiated in good faith and have come to an Agreement regarding the sale of the buses; and

WHEREAS, the Federal Transit Administration (FTA) requires approval from the agency's governing board approving the transfer of buses from one FTA grantee to another FTA grantee; and


WHEREAS, the City recently received "grantee" status, which allowed the City to finalize an Agreement with SCAT and METRO to transfer the buses; and

WHEREAS, the delivery of these buses will greatly improve the reliability of commuter transit service and allow Elk Grove to be in compliance with the California Air Resources Board beyond 2007.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove does authorize:


- 1) The Federal Transit Administration (FTA) to transfer 26 buses from South Coast Area Transit (SCAT) and 13 buses from METRO Regional Transit Authority (METRO) to the City of Elk Grove; and
- 2) The City Manager to sign the bill of sale for the METRO buses.



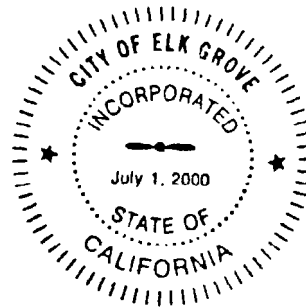
