

**RESOLUTION NO. 2007-160**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE FISCAL YEAR 2007-08  
MEASURE A ALLOCATION AND EXPENDITURE CONTRACT BETWEEN THE CITY  
AND THE SACRAMENTO TRANSPORTATION AUTHORITY**

**WHEREAS**, the Sacramento Transportation Authority (STA) has approved the 2007-08 Measure A revenue estimate and distribution of funds to eligible agencies within Sacramento County;

**WHEREAS**, the City's Fiscal Year 2007-08 Measure A distribution is estimated to be \$6,789,156;

**WHEREAS**, in order to be reimbursed for its Fiscal Year 2007-08 Measure A fund expenditure in the amount of \$6,789,156, the City has submitted a Fiscal Year 2007-08 Measure A Expenditure Plan Request to the STA; and

**WHEREAS**, the STA has prepared the Fiscal Year 2007-08 Measure A Allocation and Expenditure Contract that provides the controls necessary to reimburse the City for the expenditures identified in the Fiscal Year 2007-08 Measure A Expenditure Plan.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Fiscal Year 2007-08 Measure A Allocation and Expenditure Contract between the City and the Sacramento Transportation Authority.


