**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE

PROJECT AS COMPLETE AND AUTHORIZING THE CITY ENGINEER TO  
PREPARE A NOTICE OF COMPLETION AND THE CITY CLERK TO FILE THE  
NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on March 8, 2006, the City Council authorized the award of a contract to Centerline Striping, Inc. to construct the Street Name Sign and Stop Sign Replacement 2006 Project;

**WHEREAS**, the contract called for the construction and installation of street name and stop signs;



**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Street Name Sign and Stop Sign Replacement 2006 Project with the Sacramento County Recorder.


