**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
GRANTING EXCLUSIVE RECOGNITION TO
THE ELK GROVE POLICE OFFICERS' ASSOCIATION
REPRESENTING POLICE DEPARTMENT EMPLOYEES AS SPECIFIED**

WHEREAS, all City labor relations have been regulated by the Meyers-Milias-Brown Act (MMBA) and City promulgated employer-employee rules; and

WHEREAS, on October 22, 2008, the Elk Grove Police Officers' Association (EGPOA) submitted a petition requesting to be recognized as the exclusive representative for the employees in designated classifications representing police department employees; and

WHEREAS, the EGPOA has met all the terms of the Employee Employer Relations Policy.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Grants exclusive recognition to the Elk Grove Police Officers' Association for the purpose of representing Police Department employees in the classifications of Police Officer, Police Sergeant, Police Records Supervisor, Police Records Technician, Police Security Officer, Police Services Technician, Police Services Supervisor, Property and Evidence Technician, Crime Analyst, Crime Prevention Analyst, Dispatcher, Dispatch Supervisor, Community Service Officer, Forensic Technician and Senior Forensic Technician in all matters of collective bargaining and employee/employer relations.




