

RESOLUTION NO. 2008-33

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO AUTHORIZE THE CITY MANAGER, OR HIS DESIGNEE, TO EXPEND \$139,320 FROM THE TREE MITIGATION FUND FOR THE SACRAMENTO TREE FOUNDATION NATURE PROGRAM NATIVE OAK PLANTING PROJECT IN THE CITY OF ELK GROVE

WHEREAS, Chapter 19.12.220 of the City of Elk Grove Municipal Code establishes a tree preservation fund, officially titled the Tree Mitigation Fund; and

WHEREAS, the purpose of the Tree Mitigation Fund is to fund tree planting efforts, tree preservation programs, and public education programs regarding trees; and

WHEREAS, the Sacramento Tree Foundation has presented a proposal to the City to implement an oak tree planting project; and


WHEREAS, Cosumnes Community Services District staff supports the proposed plantings; and

WHEREAS, said oak tree planting project is consistent with the provisions of the Tree Mitigation Fund; and

WHEREAS, the City of Elk Grove desires to expend tree mitigation funds for the Sacramento Tree Foundation NATURE Program Native Oak Planting Project in the City of Elk Grove.


NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Elk Grove authorizes the City Manager or his designee to expend \$139,320 from the Tree Mitigation Fund for the Sacramento Tree Foundation NATURE Program Native Oak Planting Project.


