

**RESOLUTION NO. 2008-36**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ESTABLISHING AN INSTALLATION AND MAINTENANCE FEE FOR  
THE MANDATORY ONSITE NOTICING REQUIREMENT FOR PENDING  
PRIVATE DEVELOPMENT PROJECTS**

**WHEREAS**, the City Council of the City of Elk Grove has reviewed the proposed parameters for the City's Mandatory Onsite Project Noticing/Signage Program; and

**WHEREAS**, the City Council of the City of Elk Grove has amended Article II, Section 23.14.040 of the Zoning Code to establish a Mandatory Onsite Noticing requirement for pending development projects covered by Ordinance No. 3-2008 (the "Ordinance"), which provides that the Council would establish a fee for signage; and

**WHEREAS**, the City Council of the City of Elk Grove adopted Ordinance No. 23-2003 on August 3, 2003, which also authorizes the City Council to establish fees from time to time by resolution; and


**WHEREAS**, the City Council of the City of Elk Grove finds and declares that a fee is necessary to fund the costs of installation and maintenance of Mandatory Onsite Project Noticing as follows

1. Installation of Mandatory Onsite Project Noticing (\$250.00),
2. Maintenance of Mandatory Onsite Project Noticing (\$100.00); and

**WHEREAS**, the City Council of the City of Elk Grove finds that the fee set forth herein does not exceed the estimated amount required to provide the onsite signage service:

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby establishes an Onsite Signage Fee of a total of \$350.00 for installation and maintenance of Mandatory Onsite Project Noticing; effective date to coincide with Ordinance No. 3-2008 on March 14, 2008.


