

**RESOLUTION NO. 2008-81**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE PURCHASING OFFICER TO EXERCISE THE SALE AND  
DISPOSAL OF SURPLUS CITY PROPERTY IN THE FORM OF POLICE PATROL  
AND DETECTIVE VEHICLES**

**WHEREAS**, in September 2005, the City Council approved the purchase of the police fleet from the Sacramento County Sherriff's Department; and

**WHEREAS**, the City Council authorized the purchase of new vehicles to replace aging vehicles that were part of the fleet purchased from the County; and

**WHEREAS**, City Ordinance 6-2007 specifies the terms and conditions for the disposition of surplus City property, and;

**WHEREAS**, the City of Elk Grove desires to surplus five (5) vehicles and sell or dispose of the assets at fair market value.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the Purchasing Officer, to exercise the sale or disposal of surplus property in the form of five (5) police patrol and detective vehicles. Monies from the sale or disposal of surplus police patrol and detective vehicles will be deposited into the City General Fund.

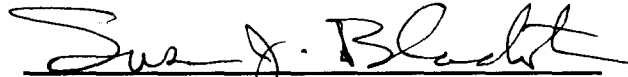
