**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE-FLORIN ROAD / CAMPBELL ROAD INTERSECTION
IMPROVEMENTS AND THE FRANKLIN BOULEVARD / WILLARD PARKWAY
INTERSECTION IMPROVEMENTS PROJECT AS COMPLETE AND AUTHORIZING
THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION AND THE CITY
CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO
COUNTY RECORDER**

WHEREAS, on September 26, 2007, the City Council authorized the award of a contract to Biondi Paving, Inc. to construct the Elk Grove-Florin Road/Campbell Road intersection improvements and the Franklin Boulevard/Willard Parkway intersection improvements (Project) (Capital Improvements Project ID PT0066); and

WHEREAS, the Project work included construction and modification of raised medians, pavement delineation modifications, signing, and other associated work to facilitate the establishment of quiet zones in the City of Elk Grove; and

WHEREAS, Biondi Paving, Inc. has since completed the work in accordance with the contract for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Biondi Paving, Inc.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby accepts the Elk Grove-Florin Road/Campbell Road intersection improvements and the Franklin Boulevard/Willard Parkway intersection improvements as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Elk Grove-Florin Road/Campbell Road intersection improvements and the Franklin Boulevard/Willard Parkway intersection improvements with the Sacramento County Recorder.


