

RESOLUTION NO. 2009-18

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO WAIVE COMPETITIVE BIDDING AND
EXECUTE AN AGREEMENT WITH HOBLIT MOTORS FOR THE PURCHASE OF
TEN (10) POLICE PATROL VEHICLES IN AN AMOUNT NOT TO EXCEED \$248,000**

WHEREAS, the City of Elk Grove's Fleet Services maintains all City vehicles including replacement when necessary; and

WHEREAS, the City's Fleet Services has identified five (5) patrol vehicles that have reached their useful life and five (5) that have collision damage beyond repair; and

WHEREAS, pursuant to Elk Grove's Purchasing Ordinance codified in Municipal Code Chapter 3.42 under section 3.42.140(B)(4), the City Council may waive the competitive bidding process when a purchase is processed through a cooperative purchasing agreement with another public agency whose procurement process is consistent with the City of Elk Grove; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of police patrol vehicles and Hoblit Motors met all of the criteria and was selected as the lowest bidder; and

WHEREAS, there is sufficient funding identified in the Fleet Services budget and Risk Management Loss Recovery fund for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with Hoblit Motors for the purchase of ten (10) police patrol vehicles in an amount not to exceed \$248,000.


