**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO
AUTHORIZE THE CITY MANAGER TO EXPEND \$154,798 FROM THE TREE
MITIGATION FUND FOR CITY OF ELK GROVE GREENPRINT PROGRAM TREE
PLANTINGS**

WHEREAS, Chapter 19.12.220 of the City of Elk Grove Municipal Code establishes a tree preservation fund, officially titled the Tree Mitigation Fund; and

WHEREAS, the purpose of the Tree Mitigation Fund is to fund tree planting efforts, tree preservation programs, and public education programs regarding trees; and

WHEREAS, the Sacramento Tree Foundation has presented a proposal to the City to implement native oak tree planting projects as part of its Native Trees in Urban and Rural Environments (NATURE) Program; and

WHEREAS, the Cosumnes Community Services District supports the proposed plantings; and

WHEREAS, oak tree planting projects are consistent with the provisions of the Tree Mitigation Fund and the Greenprint program; and

WHEREAS, the City of Elk Grove desires to expend tree mitigation funds for the City of Elk Grove Greenprint Program tree plantings.

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Elk Grove authorizes the City Manager or her designee to expend \$154,798 from the Tree Mitigation Fund for City of Elk Grove Greenprint Program Tree Plantings.
