

**RESOLUTION NO. 2009-113**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
REPEALING RESOLUTION NO. 2009-49 AND REPLACING IT WITH THE  
ATTACHED UPDATED PARKING VIOLATION FINE SCHEDULE THAT  
IMPLEMENTS ADDITIONAL CALIFORNIA STATE MANDATED SURCHARGES  
AS IDENTIFIED IN GOVERNMENT CODES 76100, 76101, AND 70371**

**WHEREAS**, Government Codes 76100, 76101, and 70371 require the City to remit a total of \$9.50 in various State mandated surcharges for each parking violation issued; and

**WHEREAS**, by Resolution No. 2009-49, the City is currently collecting only \$8.00 from parking violators, yet remitting \$9.50 as required by State law; and

**WHEREAS**, the City desires to pass along all State mandated parking violation surcharges to those who violate parking laws; and

**WHEREAS**, California Vehicle Code 9559 requires jurisdictions to collect fines in whole dollars; and

**WHEREAS**, the attached Exhibit sets forth the amount of parking violation fines to be collected in the City of Elk Grove by fully remitting the state surcharges detailed above.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove:

- 1) Adopts the attached parking violation fine schedule attached hereto as Exhibit A and incorporated herein by this reference; and
- 2) To the extent that any provision of this Resolution conflicts with the provisions of Resolution No. 2009-49, this Resolution shall control.


