

**RESOLUTION NO. 2009-221**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE WEST STOCKTON BOULEVARD BRIDGE REPLACEMENT  
OVER LAGUNA CREEK PROJECT AS COMPLETE AND AUTHORIZING THE CITY  
ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on March 25, 2009, the City Council authorized the award of a construction contract to Flatiron West, Inc. to construct the West Stockton Boulevard Bridge Replacement over Laguna Creek Project (Capital Improvement Project ID PT0033) (Project); and

**WHEREAS**, the project replaced a bridge constructed in 1956, that was identified as "functionally obsolete" by the City, the California Department of Transportation, and the Federal Highway Administration with a new longer, wider, and higher bridge over Laguna Creek; and


**WHEREAS**, Flatiron West, Inc. has completed the work in accordance with the contract for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Flatiron West, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


