

**RESOLUTION NO. 2009-251**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT  
WITH DOWNTOWN FORD SALES OF SACRAMENTO FOR VEHICLE  
MAINTENANCE AND REPAIR OF THE CITY'S FLEET OF VEHICLES EXTENDING  
THE CONTRACT TERM ONE YEAR AND AUTHORIZING AN EXPENDITURE OF  
FUNDS NOT TO EXCEED \$300,000**

**WHEREAS**, maintenance of the City's fleet vehicles is necessary to deliver service to the residents and businesses of Elk Grove; and

**WHEREAS**, the current vehicle maintenance and service contract that was the result of an open Request for Quotations terminates no later than December 15, 2009; and

**WHEREAS**, the City has engaged Downtown Ford Sales of Sacramento to provide vehicle maintenance and repair services; and

**WHEREAS**, Downtown Ford Sales of Sacramento has satisfactorily provided vehicle maintenance and repair services for the City of Elk Grove's fleet.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to amend the contract with Downtown Ford Sales of Sacramento for maintenance and repair for City vehicles, extending the contract term for one (1) year until December 15, 2010, and authorizing an expenditure of funds not to exceed \$300,000.


