

RESOLUTION NO. 2010-97

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION
CONTRACT WITH B & B ASPHALT INC. FOR THE CORPORATION YARD
IMPROVEMENTS (ELKMONT WAY ENTRANCE REPLACEMENT) PROJECT FOR
AN AMOUNT NOT TO EXCEED \$83,351 AND AUTHORIZING THE CITY ENGINEER
TO APPROVE CHANGE ORDERS NOT TO EXCEED \$20,000**

WHEREAS, the City has an urgent need to repair the Elkmont Way Entrance to the Corporation Yard due to significant deterioration of the pavement surface; and

WHEREAS, the drawings and specification for the Elkmont Entrance Replacement have been completed and reviewed by Public Works staff to assure a functional and safe entry for large vehicles; and

WHEREAS, the California Environmental Quality Act (CEQA) guidelines Section 15301 exempts projects that only involve minor alternations and repairs to existing City facilities and no expansion of the existing use from environmental review; and

WHEREAS, funding for the Elk Grove Corporation Yard Improvements (Elkmont Way Entrance Replacement) Project has been identified as \$103,351 from the Corporation Yard Miscellaneous Improvement Fund account 602-1810-418.64-00; and

WHEREAS, an invitation to bid was duly advertised on April 7, 2010, bids were opened on April 29, 2010, and B & B Asphalt Inc. was determined to be the lowest responsible bidder submitting the lowest responsive bid in a public competitive bidding process.

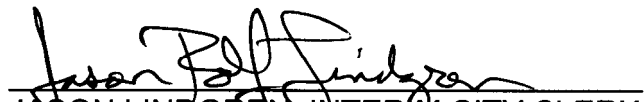
NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with B & B Asphalt Inc. for the Corporation Yard Improvements (Elkmont Way Entrance Replacement) Project in the amount of \$83,351; and
- 2) Authorizes the City Engineer to approve change orders not to exceed \$20,000.
