

RESOLUTION NO. 2010-141

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH BIONDI PAVING, INC. FOR THE BOND ROAD AT EAST STOCKTON BOULEVARD MEDIAN ISLAND IMPROVEMENT PROJECT AND THE ELK GROVE BOULEVARD AT LAGUNA SPRINGS DRIVE MEDIAN ISLAND IMPROVEMENT PROJECT IN THE AMOUNT OF \$48,188 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT TO EXCEED \$9,600**

**WHEREAS**, the Bond Road at East Stockton Boulevard Median Island Improvement Project and the Elk Grove Boulevard at Laguna Springs Drive Median Island Improvement Project are budgeted within the approved Fiscal Year 2009-10 budget; and

**WHEREAS**, an invitation to bid was duly advertised on April 16, 2010 and the City Clerk did not receive any bids on Thursday, May 14, 2010; and

**WHEREAS**, an invitation to bid was duly re-advertised on May 18, 2010, bids were opened on June 17, 2010, and Biondi Paving, Inc. was determined to be the responsible bidder submitting the lowest responsive bid.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Finds that the project is exempt from environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA guidelines Section 15301 (c) and (f) of Title 14 of the California Code of Regulations; and
- 2) Authorizes the City Manager to execute a construction contract with Biondi Paving, Inc. for the Bond Road at East Stockton Boulevard Median Island Improvement Project and the Elk Grove Boulevard at Laguna Springs Drive Median Island Improvement Project in the amount of \$48,188; and
- 3) Authorizes the City Engineer to approve change orders not to exceed \$9,600.
