

**RESOLUTION NO. 2010-239**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE  
COUNTY OF SACRAMENTO MUNICIPAL SERVICES AGENCY FOR THE  
PREPARATION OF THE ENVIRONMENTAL DOCUMENTS FOR THE KAMMERER  
ROAD EXTENSION PROJECT NOT-TO-EXCEED \$645,847**

**WHEREAS**, the East Franklin Specific Plan and the Elk Grove General Plan both identify the need for a major arterial road south of Bilby Road connecting Interstate 5 with State Route 99; and

**WHEREAS**, the City of Elk Grove desires to study the Kammerer Road Extension (Lent Ranch Parkway to Hood Franklin Road); and

**WHEREAS**, the project is mostly in unincorporated area of Sacramento County, and the City has determined it is most efficient and cost effective to have the County perform the majority of the environmental phase work; and

**WHEREAS**, Sacramento County Department of Environmental Review and Assessment (DERA) staff will invoice the City for actual time with a not-to-exceed amount identified; and

**WHEREAS**, the City and County staff have developed a scope of work for the County based on developing an Environmental Impact Report under the California Environmental Quality Act and an Environmental Assessment under the National Environmental Policy Act.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with the County of Sacramento Municipal Services Agency for the preparation of the environmental documents for the Kammerer Road Extension Project not-to-exceed \$645,847.
