

**RESOLUTION NO. 2010-236**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION  
CONTRACT WITH JM SLOVER, INC. FOR THE WHITELOCK PARKWAY  
LANDSCAPE AND PEDESTRIAN IMPROVEMENTS PROJECT IN THE AMOUNT OF  
\$160,252.05 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE  
ORDERS NOT-TO-EXCEED \$25,000**

**WHEREAS**, the Whitelock Parkway Landscape and Pedestrian Improvements Project is included in the approved 2011-15 Capital Improvement Program and is budgeted within the approved Fiscal Year 2010-11 Budget; and

**WHEREAS**, an invitation to bid was duly advertised on September 8, 2010, bids were opened on October 7, 2010, and JM Slover, Inc. was determined to be the lowest responsible bidder submitting the lowest responsive bid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Finds that the Whitelock Parkway Landscape and Pedestrian Improvements Project is exempt from environmental review pursuant to section 15301 of the California Environmental Quality Act guidelines; and
- 2) Authorizes the City Manager to execute a construction contract with JM Slover, Inc. for the Whitelock Parkway Landscape and Pedestrian Improvements Project in the amount of \$160,252.05 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 3) Authorizes the City Engineer to approve change orders not-to-exceed \$25,000.00.
