A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING
THE CORPORATION YARD MISCELLANEOUS IMPROVEMENTS PROJECT
(PF0017) PROJECT DESCRIPTION, AMENDING THE 2010-15 CAPITAL
IMPROVEMENT PROGRAM AND THE FISCAL YEAR 2010-11 BUDGET BY
APPROVING THE ALLOCATION OF \$168,000 OF CAPITAL FACILITIES FEE –
CORPORATION YARD FUNDING AND \$432,000 OF FACILITY RESERVE FUNDING
FOR THE PROJECT

WHEREAS, the City Council established the Corporation Yard Miscellaneous Improvements Project (PF0017) to improve efficiency and operations; and

WHEREAS, on September 16, 2010 the City Planning Commission found the Corporation Yard Facilities Master Plan and Transit Yard Master Plan consistent with the City's General Plan and modified the Corporation Yard Improvements Project description to include operations as specified in those Master Plans; and

WHEREAS, on October 27, 2010 the City Council adopted the Corporation Yard Facilities Master Plan and Transit Yard Master Plan and adopted a Mitigated Negative Declaration consistent with the requirements of the California Environmental Quality Act (CEQA); and

WHEREAS, the City has undertaken negotiations for the purchase of an adjacent property consistent with the Corporation Yard Facilities Master Plan; and

WHEREAS, funding is needed to finance the property acquisition.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Corporation Yard Miscellaneous Improvements Project (PF0017) description to read:

"This project addresses both long- and short-term improvements necessary for continued efficiency of operations as specified in the Corporation Yard Facilities Master Plan and Transit Yard Master Plan."

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby amends the 2010-15 Capital Improvement Program and the Fiscal Year 2010-11 Budget by approving the allocation of \$168,000 of Capital Facilities Fee – Corporation Yard funding and \$432,000 of Facility Reserve funding for the Corporation Yard Miscellaneous Improvements Project (PF0017).
