

RESOLUTION NO. 2011-28

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE JANITORIAL SERVICES CONTRACT FOR CITY FACILITIES WITH ABLE BUILDING MAINTENANCE OF SACRAMENTO EXTENDING THE TERM FOR TWO YEARS AND AUTHORIZING AN EXPENDITURE OF FUNDS IN THE AMOUNT OF \$196,000 FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$489,259

WHEREAS, building cleanliness of the City's facilities is necessary in delivering service to the citizens of the City of Elk Grove; and


WHEREAS, in September of 2007, the City released a Request for Proposals soliciting a contract for Janitorial Services, and Able Building Maintenance of Sacramento was successful in this process and was awarded Contract No. C-08-002; and

WHEREAS, the City has engaged Able Building Maintenance to provide the City with Janitorial services for the past three years; and

WHEREAS, Staff has found the level of service provided by Able Building Maintenance of Sacramento to be both highly satisfactory and cost effective. Able Building Maintenance has validated its janitorial service experience.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment to the contract with Able Building Maintenance by extending the contract term for two years for janitorial services for City facilities and authorizing the expenditure of funds in an amount not-to-exceed \$196,000 for a total compensation amount not-to-exceed \$489,259.
