**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2010-11 TRANSPORTATION
DEVELOPMENT ACT CLAIM AND AUTHORIZING ITS SUBMISSION BY THE
CITY MANAGER TO THE SACRAMENTO AREA COUNCIL
OF GOVERNMENTS FOR LOCAL TRANSPORTATION FUNDS
AND STATE TRANSIT ASSISTANCE FUNDS**

WHEREAS, the State of California enacted the Transportation Development Act (TDA) in 1972 to provide funds for transportation needs each fiscal year; and


WHEREAS, the Sacramento Area Council of Governments (SACOG) is designated as the Regional Transportation Planning Agency for the six county metropolitan area, which includes the City of Elk Grove, to receive claims for approval pursuant to the TDA rights and regulations; and

WHEREAS, SACOG has adopted a revised finding of apportionment for State Transit Assistance Funds and Local Transportation Funds for Fiscal Year 2010-11 for Sacramento County.

NOW, THEREFORE, BE IT RESOLVED that the amended Fiscal Year 2010-11 Transportation Development Act (TDA) Claim is hereby approved and authorized for submission to the Sacramento Area Council of Governments (SACOG) by the City Manager, or her designee, for Local Transportation Funds (LTF) and State Transit Assistance (STA) funds.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Manager, or her designee, is hereby authorized to make the necessary budget amendments, transfers, accounting entries, and claim amendments to carry out the City Council's policies and directives pertaining to this matter.


