

**RESOLUTION NO. 2011-45**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE WAIVING THE COMPETITIVE BIDDING REQUIREMENTS AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH A-Z BUS SALES FOR VEHICLE REPAIR FOR AN AMOUNT NOT-TO-EXCEED \$150,000**

**WHEREAS**, in May 2010, the City received a formal transfer from the Federal Transit Administration of ten (10) Bluebird buses from Unitrans; and

**WHEREAS**, the City of Elk Grove requires these vehicles to replace buses currently in service which have expiring Compressed Natural Gas (CNG) tanks; and

**WHEREAS**, A-Z Bus Sales ("A-Z") is familiar with Bluebird buses and works on the City's CNG transit fleet, and continued use of A-Z's services will avoid duplication of effort if several maintenance vendors were required; and


**WHEREAS**, the City Manager authorized a purchase order to A-Z for vehicle repairs on July 26, 2010; and

**WHEREAS**, the cost of the vehicle repairs now appears that it will exceed the City Manager's purchasing authority.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove does hereby waive the procurement process per Elk Grove Municipal Code Section 3.42.130 (B).

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove does hereby authorize the City Manager to execute an agreement with A-Z Bus Sales for vehicle repair in an amount not-to-exceed \$150,000.
