

RESOLUTION NO. 2011-76

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
U.S. DEPARTMENT OF JUSTICE DRUG ENFORCEMENT ADMINISTRATION FOR
THE PURPOSE OF ERADICATING MARIJUANA CULTIVATION AND AMENDING
THE POLICE DEPARTMENT'S FISCAL YEAR 2010-11 BUDGET TO APPROPRIATE
GRANT FUNDS IN THE AMOUNT OF \$25,000**

WHEREAS, in December 2010, the U.S. Department of Justice Drug Enforcement Administration announced funding opportunities for local law enforcement agencies interested in implementing marijuana cultivation eradication operations; and

WHEREAS, the U.S. Department of Justice Drug Enforcement Administration has awarded the Elk Grove Police Department a grant in the amount of \$25,000 to implement programs to eradicate marijuana cultivation; and

WHEREAS, these grant funds will allow the Police Department to work additional hours to investigate illegal marijuana cultivation in the City of Elk Grove; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept a grant award from the U.S. Department of Justice Drug Enforcement Administration for the purpose of eradicating marijuana cultivation in the amount of \$25,000; and
- 2) Execute all related award documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Police Department's revenue and expense budgets as follows:






