

**RESOLUTION NO. 2011-84**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO RELEASE A PURCHASE ORDER  
TO LNI CUSTOM MANUFACTURING, INC. FOR BUS SHELTERS AND FIXTURES  
FOR THE CITYWIDE BUS STOP IMPROVEMENTS PROJECT – PHASE 1  
IN THE AMOUNT OF \$207,728.69**

**WHEREAS**, on March 28, 2007 the City Council approved the purchasing contract with LNI Custom Manufacturing, Inc. (LNI) with an initial purchase order for sixteen (16) bus shelters and fixtures; and

**WHEREAS**, the purchasing contract allows for the subsequent purchases of bus shelters and fixtures as funds become available; and


**WHEREAS**, the purchasing contract has a term beginning April 1, 2007 and terminating March 31, 2012; and

**WHEREAS**, federal grant funding was secured for the purchase of 29 bus shelters and fixtures for The Citywide Bus Stop Improvements Project – Phase 1 (PF014A); and

**WHEREAS**, the purchasing contract with LNI was awarded to LNI based on a competitive process in conformance with the Public Contract Code sections 20160-20175.2 et seq., because the contract was publicly advertised and awarded to the lowest bidder.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to release a purchase order with LNI Custom Manufacturing, Inc. for 29 bus shelters and fixtures for Phase 1 of the Citywide Bus Stop Improvements Project in the amount of \$207,728.69.
