

**RESOLUTION NO. 2011-114**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT TERMINATION  
DATE WITH MCE CORPORATION FOR A PERIOD OF UP TO SIX MONTHS,  
TERMINATING NO LATER THAN DECEMBER 31, 2011 AND AUTHORIZING A 10%  
BILLING RATE INCREASE FOR THREE VEHICLES WITH NO INCREASE IN  
CONTRACT AUTHORIZATION NECESSARY**

**WHEREAS**, the City currently contracts with MCE Corporation (MCE) for general Public Works services such as pavement repair, re-striping, and traffic sign repair; and

**WHEREAS**, the current contract between MCE and the City expires June 30, 2011; and

**WHEREAS**, the City Council gave direction to staff to solicit a single prime contractor to execute all operations in the Department of Public Works, including the work currently performed by MCE; and


**WHEREAS**, general services required by the City are to be competitively bid by the prime Public Works contractor, Willdan Engineering; and

**WHEREAS**, there is insufficient time for Willdan Engineering to pursue a competitive bidding process and execute contracts for public works general services prior to the expiration of the existing contract with MCE; and

**WHEREAS**, the services provided by the existing contract with MCE Corporation are critical to ongoing public and traffic safety, because they respond to urgent issues that can cause road closures or traffic accidents and should therefore not lapse.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to extend the contract termination date with MCE Corporation for a period of up to six months, terminating no later than December 31, 2011, and approving a 10% increase in billing rates for three pieces of equipment. No other rate increases have been requested, and no increase in contract authority is necessary to cover this request. Total compensation not-to-exceed \$12,981,000 for the four and one half year period.


