

RESOLUTION NO. 2011-132

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE
US DEPARTMENT OF JUSTICE TO PROVIDE PROSECUTION SERVICES FOR
CRIMES COMMITTED IN THE CITY OF ELK GROVE, EXECUTE ALL DOCUMENTS
NECESSARY TO RECEIVE \$54,000 IN ELIGIBLE GRANT FUNDING, AND AMEND
THE POLICE DEPARTMENT FISCAL YEAR 2011-12 BUDGET**

WHEREAS, the US Department of Justice administers the Edward Byrne Memorial Justice Assistance Grant (JAG) Program; and

WHEREAS, the JAG is a grant program whereby grant funds are made available to local jurisdictions based on population and crime statistics; and

WHEREAS, the City of Elk Grove is eligible to receive \$54,000 based on its population and crime statistics; and

WHEREAS, there are no General Fund match requirements under this grant program; and

WHEREAS, the US Department of Justice requires that the City's governing body approve the grant application by Resolution.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit an application to the US Department of Justice to provide prosecution services for crimes committed in the City of Elk Grove; 2) execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the US Department of Justice; and 3) amend the Police Department's revenue and expense budget in the amount of \$54,000.


