**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT AWARD FROM THE
OFFICE OF TRAFFIC SAFETY TO IMPLEMENT TRAFFIC SAFETY PROGRAMS IN
THE AMOUNT OF \$160,000 AND AMEND THE POLICE DEPARTMENT FISCAL
YEAR 2011-12 REVENUE AND EXPENSE BUDGETS**

WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and

WHEREAS, the Office of Traffic Safety provides grant funding to local law enforcement agencies to implement traffic safety programs; and

WHEREAS, the Police Department has been awarded \$160,000 from the Office of Traffic Safety to implement traffic safety programs in Elk Grove.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to: 1) accept a grant award in the amount of \$160,000 from the Office of Traffic Safety; 2) execute all contracts, reports and other documents required for receiving such funds pursuant to the terms and conditions of the grant; and 3) amend the Police Department's revenue and expense budgets as follows:


