

RESOLUTION NO. 2011-230

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT
WITH ELK GROVE BUICK GMC OF ELK GROVE TO SERVICE AND REPAIR
CITY OWNED GENERAL MOTORS VEHICLES IN AN AMOUNT
NOT-TO-EXCEED \$50,000**

WHEREAS, the City of Elk Grove's Fleet division maintains City vehicles including mechanical, structural and aesthetic standards; and


WHEREAS, in October of 2011 the City conducted a formal request for quotations to seek economies of scale and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

WHEREAS, Elk Grove Buick GMC met all of the criteria in the request for quotations that was the lowest bidder and was determined to be the most advantageous to the City; and

WHEREAS, Fleet Services has sufficient funding identified in its Fiscal Year 2011-12 operating budget for this service.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract with Elk Grove Buick GMC to service and repair City owned General Motors vehicles in an amount not-to-exceed \$50,000, and authorizes the City Manager, in the City Manager's discretion, to execute one additional two-year extension, as provided for in the contract, for an amount not-to-exceed \$16,666 per year during the extension period.
