A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2011-12 BUDGET, ALLOCATING FUNDS AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH CREATIVE BUS SALES FOR TWO PARATRANSIT BUSES IN AN AMOUNT NOT-TO-EXCEED \$165,000

WHEREAS, the City of Elk Grove has been allocated \$180,000 in State Transit Assistance Funds; and

WHEREAS, Transit and Facilities and Fleet Staff have identified valid contracts for paratransit buses from Creative Bus Sales; and

WHEREAS, the procurement is compliant with both the Federal Transit Administration procurement practices and the City's Purchasing Code, Elk Grove Municipal Code Chapter 3.42, which will allow the City to meet our fleet needs to deliver transit services to the residents of Elk Grove; and

WHEREAS, the City's Transit System Manager and Facilities and Fleet Manager will visit the Creative Bus Sales factory prior to delivery to inspect the vehicles in accordance with Federal Transit Administration (FTA) Best Practices and complete the required Buy America certifications.

NOW, **THEREFORE**, **BE IT RESOLVED** that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2011-12 Budget, allocates funds and authorizes the City Manager to execute the Contract with Creative Bus Sales for two paratransit buses in an amount not-to-exceed \$165,000.
