**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE ELK GROVE CREEK PIPE OUTFALLS AND DRY WELL  
INSTALLATIONS DRAINAGE IMPROVEMENTS PROJECTS AS COMPLETE AND  
AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION  
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE  
SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on December 14, 2011, the City Council awarded a construction contract to North West Surfacing to construct the Elk Grove Creek Pipe Outfalls and Dry Well Installations Drainage Improvements Projects (Capital Improvement Project ID WDR004 and WDR012) (Projects); and


**WHEREAS**, North West Surfacing has completed the work in accordance with the contract documents for the Projects; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to North West Surfacing.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Elk Grove Creek Pipe Outfalls and Dry Well Installations Drainage Improvements Projects (Projects) as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Projects with the Sacramento County Recorder.


