

**RESOLUTION NO. 2012-123**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE COMPETITIVE BID PROCESS AND AUTHORIZING  
THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS  
TO UTILIZE CALIFORNIA STATE CONTRACTS FOR THE PURCHASE OF  
COMPUTER EQUIPMENT FOR THE EMERGENCY OPERATIONS CENTER  
IN AN AMOUNT NOT-TO-EXCEED \$317,690**

**WHEREAS**, the City adopted Resolution No. 2010-185 in August 2010, to accept grant funding of \$750,000 from the California Emergency Management Agency to establish an Emergency Operation Center; and

**WHEREAS**, a portion of the project includes purchasing necessary computer equipment to be able to use the facility in the event of an emergency; and


**WHEREAS**, Elk Grove Municipal Code Subsection 3.42.180(B)(4) allows the City Council to dispense with competitive bidding when processed through a cooperative purchasing agreement with another public agency whose procurement process is consistent with the provisions of Elk Grove Municipal Code Chapter 3.42 Contracts and Purchasing; and

**WHEREAS**, the State of California maintains cooperative purchasing agreements for the equipment needed by the City; and

**WHEREAS**, the Emergency Operation Center Project has sufficient funding, as provided by the grant award from the California Emergency Management Agency.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with competitive bidding and authorizes the City Manager to execute all necessary documents to utilize California State Contracts for the purchase of computer equipment for the Emergency Operations Center, as set forth on Exhibit A, attached hereto, in an amount not-to-exceed \$317,690.


