

**RESOLUTION NO. 2012-178**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF  
UNDERSTANDING AND RELATED AGREEMENTS WITH THE SACRAMENTO  
TRANSPORTATION AUTHORITY FOR MEASURE A ONGOING  
ANNUAL CAPITAL PROGRAM EXPENDITURES**

**WHEREAS**, in November 2004, Sacramento County (County) voters approved a continuance of the Measure A Transportation Sales Tax Program, wherein a one-half of one percent sales tax is collected within the County to be dedicated to transportation improvements for a period of thirty (30) years, effective April 1, 2009; and

**WHEREAS**, sales tax revenue must be used in accordance with voter-approved transportation project improvements and programs; and


**WHEREAS**, the City receives Measure A funding for the following ongoing annual capital programs: 1) City Street and County Road Maintenance, 2) Traffic Control and Safety Program, and 3) Safety, Streetscaping, Pedestrian, and Bicycle Facilities Program; and

**WHEREAS**, annually, the Sacramento Transportation Authority (STA) prepares a Memorandum of Understanding (MOU) to ensure that Measure A funds are expended exclusively on eligible expenditures and to also establish a mechanism for the distribution of sales tax revenue by the STA to the City; and

**WHEREAS**, the MOU must be approved annually in order for the City to receive reimbursement for program expenditures each fiscal year.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Memorandum of Understanding and related agreements with the Sacramento Transportation Authority for Measure A Ongoing Annual Capital Program expenditures for Fiscal Year 2012-13.
