RESOLUTION NO. 2012-227

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AND CONFIRMING THE REPORT OF DELINQUENT SPECIAL ASSESSMENT AND REQUESTING SACRAMENTO COUNTY TO COLLECT SUCH CHARGES ON THE FISCAL YEAR 2012-13 TAX ROLL

WHEREAS, the City of Elk Grove (the "City") has adopted a Municipal Code to establish standards for property maintenance; and

WHEREAS, the Municipal Code standards are intended to maintain public health and safety and quality of life for Elk Grove's residents; and

WHEREAS, violations of the Municipal Code are enforced through notices, citations, fees and fines issued and assessed by the City's Code Enforcement Division; and

WHEREAS, California Government Code Section 38773.5 grants cities the authority to make costs related to abatement of nuisances a special assessment against a parcel; and

WHEREAS, Elk Grove Municipal Code Section 16.18.1509 allows for the City Clerk to file with the Sacramento County Recorder's Office a special assessment against the title of properties delinquent on payment of abatement costs and fees; and

WHEREAS, the properties listed in the attached Exhibit A are delinquent in the payment of said special assessment and a notice of special assessment was mailed to the landowners listed in a report detailing such charges (the "Report") not less than ten days prior to the date of consideration of this matter by the City Council; and

WHEREAS, at the time and place set forth in the notice this City Council considered the Report and duly considered all protests related thereto, if any.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove:

Section 1. Confirming the Report. The City Council directs the Code Enforcement Division to make any amendments to the Report as necessary, removing parcels from the Report for which payment has been made before December 31, 2012. The City Council hereby approves, confirms, and adopts the Report, amended as authorized and attached hereto and incorporated herein by reference as Exhibit A and determines that each such charge is proper and correct.

<u>Section 2. Authorization.</u> The City Council hereby directs the City Clerk to effectuate the delivery of a certified copy of the finalized report to the Sacramento County Auditor and to submit a certified copy of the Resolution (with attachments) with the County Recorder for recordation.

Section 3. Services of Sacramento County. The offices of the Sacramento County Auditor and Sacramento County Recorder are requested to do any and all things necessary to provide for the placement of the charges on the tax roll and collecting said charges with the general taxes.

Section 4. General Authorization. The members of the City Council, the City Clerk, and the other officers of the City are hereby authorized and directed, individually and collectively, to do any and all things and to execute, deliver, and perform any and all agreements and documents that they deem necessary or advisable in order to effectuate the purposes of this Resolution. All actions heretofore taken by the officers and agents of the City that are in conformity with the purposes and intent of this Resolution are hereby ratified, confirmed, and approved in all respects.

Section 5. Effective Date. This resolution shall be effective on the 12th day of December, 2012.
