**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING DETERMINATIONS OF THE CITY ENGINEER FINDING THREE
RESPONSES TO THE CIVIC CENTER AQUATICS COMPLEX REQUEST FOR
QUALIFICATIONS AS QUALIFIED**

WHEREAS, the City Council approved the Civic Center Aquatics Complex Project Scope on November 14, 2012, to include the design, construction and operation of both a Competitive Training Facility and a Commercial Recreation Facility; and

WHEREAS, the City Council directed the solicitation of a Request for Qualifications, which was subsequently released on November 30, 2012; and

WHEREAS, four Statements of Qualification (SOQ) were received on December 21, 2012; and

WHEREAS, each SOQ is comprised of a Design / Build / Operator (D/B/O) Team; and

WHEREAS, in order for a D/B/O Team to qualify to make a proposal to the City at a future date, the prequalification questionnaire must be completed and all requested documentation must be provided to the satisfaction of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the determinations of the City Engineer that the following Design / Build / Operator Teams are qualified for the Project:

- 1) Operator-Wild Rivers
Contractor-Griffin Structures
- 2) Operator-Harvest Family Entertainment/Horizon Family Holding
Contractor-McCarthy Building
- 3) Operator-Harvest Family Entertainment/Horizon Family Holding
Contractor-Roebbelen Contracting


