

**RESOLUTION NO. 2013-49**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE LAGUNA CREEK TRAIL CONNECTION AT CAMADA COURT  
IMPROVEMENT PROJECT (WTL002) AS COMPLETE AND AUTHORIZING THE  
CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on November 14, 2012 the City Council authorized the award of a construction contract to Loduca Company to construct the Laguna Creek Trail Connection at Camada Court Project (Capital Improvement Project ID WTL002) (Project) at the end of Camada Court; and

**WHEREAS**, the Project included construction of 100 feet of 10' wide paved trail with 2' decomposed granite shoulders and a post and cable fence on each side that connects the Laguna Creek Trail to Camada Court; and


**WHEREAS**, Loduca Company has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Loduca Company.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Laguna Creek Trail Connection at Camada Court Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


