

RESOLUTION NO. 2013-72

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT WITH INFOSEND FOR UTILITY BILLING GOODS AND SERVICES, EXTENDING THE CONTRACT FOR ONE (1) THREE (3) YEAR TERM, AND AUTHORIZING AN EXPENDITURE OF \$300,000 [FOR A TOTAL EXPENDITURE OF FUNDS OVER THE CONTRACT TERM NOT-TO-EXCEED \$950,000]

WHEREAS, the City has engaged Infosend to provide the City with utility billing goods and services; and

WHEREAS, Infosend has satisfactorily provided utility billing goods and services to the City; and

WHEREAS, the current utility billing goods and services contract terminates June 25, 2013; and

WHEREAS, the City seeks efficiency and aims to provide the lowest cost service option to its residents without sacrificing quality or accuracy of service delivery; and

WHEREAS, it is beneficial to the City to continue its utility billing goods and services with Infosend due to its exceptional customer service, response time, and overall success rate; and

WHEREAS, pursuant to Elk Grove Municipal Code section 3.42.180(B)(3), for the reasons set forth herein and the accompanying staff report, it is in the best interest of the City to dispense with a competitive bidding procedure for the subject utility billing goods and services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds that compliance with the competitive bidding procedure is not in the best interest of the City, dispenses with competitive bidding, and authorizes the City Manager to execute a contract amendment with InfoSend for utility billing goods and services, extending the contract for one (1) three (3) year term, and authorizing an expenditure of \$300,000 for a total expenditure of funds over the contract term not-to-exceed \$950,000.


