

RESOLUTION NO. 2013-66

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE
SACRAMENTO OFFICE OF EMERGENCY SERVICES STATE HOMELAND
SECURITY GRANT PROGRAM FOR AN INCIDENT RESPONSE VEHICLE AND
EXECUTE ALL DOCUMENTS NECESSARY TO RECEIVE UP TO \$246,000 IN
ELIGIBLE GRANT FUNDING**

WHEREAS, the Federal Emergency Management Agency (FEMA) provides grant funding under the State Homeland Security Grant Program to improve local emergency preparedness and planning; and

WHEREAS, the Sacramento Office of Emergency Services is the local Approval Authority responsible for administering State Homeland Security grants provided under FEMA; and

WHEREAS, the Sacramento Office of Emergency Services has announced it is now accepting grant applications; and

WHEREAS, the Elk Grove Police Department recommends submitting a grant application in the amount of \$246,000 for the purchase of an incident response vehicle that will be used to support the south county of Sacramento in the event of a natural or man-made threat or disaster; and

WHEREAS, there are no General Fund match requirements under this grant program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit a grant application to the Sacramento Office of Emergency Services State Homeland Security Grant Program for an Incident Response Vehicle; 2) execute all contracts, reports and other documents required for receiving grant funding pursuant to the terms and conditions of the Office of Emergency Services; and 3) if awarded, amend the Police Department's revenue and expense budget in an amount equal to the grant award, not to exceed \$246,000.
