

RESOLUTION NO. 2013-154

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MIWALL
CORPORATION IN AN AMOUNT NOT TO EXCEED \$172,000, AND AN AGREEMENT
WITH PROFORCE MARKETING IN AN AMOUNT NOT TO EXCEED \$240,800 FOR
THE SUPPLY OF AMMUNITION FOR THE ELK GROVE POLICE DEPARTMENT**

WHEREAS, the Elk Grove Police Department has 130 sworn officer positions which require a firearm; and

WHEREAS, regular firearms training is required to maintain shooting skill and safety; and

WHEREAS, the Elk Grove Police Department must maintain a supply of ammunition for officer training, testing, and duty; and

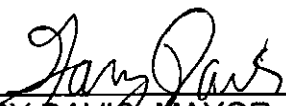
WHEREAS, staff conducted a competitive bid process to find an ammunition supplier(s) that were responsive to the City's needs and offered the lowest pricing; and

WHEREAS, ammunition is a supply item that is budgeted every year during the citywide budget process.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute:

- 1) A two year agreement, with the City's option in the City Manager's discretion to extend the agreement for up to an additional two years, with Miwall Corporation, a California corporation, in an amount not to exceed \$172,000; and
- 2) A two year agreement, with the City's option in the City Manager's discretion to extend the agreement for up to an additional two years, with ProForce Marketing, an Arizona corporation doing business as ProForce Law Enforcement, in an amount not to exceed \$240,800 for the supply of ammunition for the Elk Grove Police Department.
