**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2013-14 INFORMATION TECHNOLOGY FUND
BUDGET TO REFLECT REVENUE AND EXPENDITURES RELATED TO FUNDS
AWARDED FROM THE SACRAMENTO METROPOLITAN CABLE TELEVISION
COMMISSION IN THE AMOUNT OF \$96,621.37**

WHEREAS, the City of Elk Grove was notified that the City will be receiving \$96,621.37 from the Sacramento Metropolitan Cable Television Commission (SMCTC) in Public Education and Government (PEG) Channel Facilities fees; and

WHEREAS, the City of Elk Grove will utilize the funding to pay for necessary upgrades and replacement of audio/visual equipment in the Council Chamber; and

WHEREAS, the City will seek reimbursement from the SMCTC after the funds are expended, but before June 30, 2014.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2013-14 Information Technology Fund budget as follows:


