
**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SUB-RECIPIENT
AGREEMENT WITH THE SACRAMENTO AREA COUNCIL OF GOVERNMENTS
(SACOG) AND SUBMIT FOR REIMBURSEMENT FOR ACTIVITIES RELATED TO THE
TRANSPORTATION MANAGEMENT ASSOCIATION (TMA)**

WHEREAS, SACOG awarded the City \$29,351 in funding for activities related to the Transportation Management Association (TMA); and

WHEREAS, the City of Elk Grove will work with SACOG to implement TMA activities including: the Emergency Ride Home Program, promotion of Ride Share activities, participation in the SACOG Transportation Demand Management (TDM) Task Force, outreach to potential new members of the TMA, support TDM Goals and Strategies, provide periodic reports to governing boards, promote marketing campaigns in conjunction with SACOG, and provide an annual TDM Services Plan.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute the Sub-recipient Agreement for activities related to the TMA and submit for reimbursement totaling \$29,351 with the Sacramento Area Council of Governments in substantially the form presented in the staff report.


