

RESOLUTION NO. 2013-178

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A FIVE YEAR CONTRACT WITH
DKS ASSOCIATES FOR NEXUS STUDY PREPARATION AND CONSULTING
SERVICES IN A TOTAL NOT TO EXCEED AMOUNT OF \$76,020 OVER THE FIVE
YEAR TERM**

WHEREAS, the City of Elk Grove, in May of 2009, contracted a consultant to perform an update of the original Roadway Fee Program Nexus Study from 2005 for which, pursuant to California Government Code 66001, the City of Elk Grove is tasked with providing an updated Roadway Nexus Study every five years thereafter; and

WHEREAS, in July 2013, City Staff issued a Requests for Proposals (RFP) for Nexus Study Preparation and Consulting Services in order to seek the best value and highest quality professional services via a competitive selection process; and

WHEREAS, the proposals were reviewed by the Accounting Manager, Finance Analyst, Capital Projects Manager and Public Works Contract Manager; and

WHEREAS, staff has determined through a competitive selection process that DKS Associates demonstrated the best value with the highest quality of professional services, knowledge and professional expertise in this case providing the Roadway Impact Fee Nexus Study, while showing a clear and thorough understanding of the specific nature of this project as requested by the City in the RFP.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a five year contract with DKS Associates for nexus study preparation and consulting services in a total not to exceed amount of \$ 76,020 over the five year term.




