

**RESOLUTION NO. 2014-09**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE WATERMAN ROAD CULVERT REPLACEMENT PROJECTS NEAR  
ELK GROVE BOULEVARD AND HUDSON RANCH AS COMPLETE AND  
AUTHORIZING THE CITY ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE,  
A NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on June 26, 2013 the City Council authorized the award of a construction contract to F. Loduca Company for the Waterman Road Culvert Replacement Projects Near Elk Grove Boulevard and Hudson Ranch (Capital Improvement Project IDs WDR008 and WDR009) (the "Project"); and

**WHEREAS**, the Project removed and replaced existing deteriorated drainage culverts and reconstructed pavement at two locations on Waterman Road, one just south of Elk Grove Boulevard and the other adjacent to Hudson Ranch between Kent Street and Bradshaw Court; and

**WHEREAS**, F. Loduca Company has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to F. Loduca Company.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Waterman Road Culvert Replacement Projects Near Elk Grove Boulevard and Hudson Ranch as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


