

RESOLUTION NO. 2014-168

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH
TRANSPORTATION SERVICES INC. TO REHABILITATE SIX TRANSIT FLEET
BUSES IN AN AMOUNT NOT-TO-EXCEED \$750,000**

WHEREAS, the City of Elk Grove's Facilities and Fleet Division provides Transit Maintenance oversight; and

WHEREAS, six Transit buses acquired from Sacramento Regional Transit District (SRTD) are reaching their Compressed Natural Gas (CNG) 15-year tank life; and

WHEREAS, staff evaluated and determined overhauling of the bus engines, transmissions, reupholstering the passenger seating and replacing driver's seating was a cost effective measure to extend the vehicles' useful life; and

WHEREAS, staff applied for and was successful in obtaining Federal funding for the project and conducted a formal request for proposals in February of 2014 to seek economies of scale and thereby complied with the competitive bid requirements of Elk Grove Municipal Code Chapter 3.42 regarding contracts and purchasing; and

WHEREAS, Transportation Services, Inc. of Sacramento met all of the criteria in the request for proposal and was determined to be the lowest responsive, responsible bidder to the City; and

WHEREAS, the Elk Grove City Council passed Resolution No. 2014-24 on February 12, 2014 to receive a Sub-recipient Agreement under SACOG with SRTD for the rehabilitation of the identified six buses in an amount not to exceed \$687,746 with a 20% local match Transportation Development Act funds of \$171,937 for a total project not to exceed \$859,683.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Transportation Services, Inc. of Sacramento in an amount not-to-exceed \$750,000 to rehabilitate six Transit Fleet buses.


