

RESOLUTION NO. 2015-120

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH JACK CLANCY ASSOCIATES FOR THE POLICE EXAMINATION PROCESS FOR SERGEANT AND LIEUTENANT FOR A TERM OF ONE YEAR, IN AN AMOUNT NOT-TO-EXCEED \$18,000 WITH A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$66,000 FOR THIS VENDOR

WHEREAS, the Elk Grove Police Department believes in offering promotional opportunities to its staff and sworn officers, and understands the need for a qualified examination process and professional assessment center for promotional positions within the Police Department; and

WHEREAS, the City has contracted with Jack Clancy Associates for Police Department promotional examinations for several years, and Jack Clancy Associates has demonstrated a high level of competence and excellent service to the City in establishing the examination process and assessment center; and

WHEREAS, staff has determined that with the institutional knowledge and specialization in sworn personnel promotional examinations possessed by Jack Clancy Associates that formal solicitation will not yield results more advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), which provides an exception to the competitive bidding process when it is not in the best interest of the City, and authorizes the City Manager to execute a contract with Jack Clancy Associates for a term of one year, in an amount not-to-exceed \$18,000 with a total contract not-to-exceed amount of \$66,000 for this vendor.


