

RESOLUTION NO. 2015-160

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AND CONFIRMING THE REPORT OF DELINQUENT CHARGES AND AUTHORIZING THE FINANCE DIRECTOR TO TAKE NECESSARY ACTIONS TO EFFECTUATE THE LEVY OF DELINQUENT CHARGES IDENTIFIED IN THE REPORT

WHEREAS, the City of Elk Grove (the "City") provides certain solid waste and storm drain utility services to its residents; and

WHEREAS, it is in the best interest of the City and all rate payers for the City to pursue the most effective and secure collections actions allowable by law on all delinquent accounts for which such action is permissible under the law; and

WHEREAS, the accounts listed on The Report of Delinquent Charges (the "Report") have not paid amounts owed in a timely fashion and are subject to levy on the tax roll pursuant to Elk Grove Municipal Code Section 3.70.060 and Government Code Section 25831; and

WHEREAS, on June 26, 2015, the account holders of accounts listed in the Report were mailed a notification of the City's intention to consider placement of their delinquent charges on the tax roll at a date and time consistent with this public hearing, and on July 8 and 15, 2015, notice of the hearing was published in the *Elk Grove Citizen*, in accordance with noticing requirements; and

WHEREAS, after a hearing held at the time and place set forth in the notice, the City Council wishes to effectuate the collection of the delinquent charges on the Report through placement of the charges identified therein on the Sacramento County (the "County") tax roll.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves, confirms and authorizes:

- 1) The foregoing recitals are true and correct and this Council so determines.
- 2) The City Council directs the Director of Finance and Administrative Services to make any amendments to the Report as necessary, removing parcels from the report for which payment has been made before July 31, 2015. The City Council hereby approves, confirms and adopts the Report, amended as authorized and attached hereto as Exhibit A and incorporated herein by reference and determines that each charge is proper and correct.
- 3) The City Council hereby levies the delinquent charges identified in the confirmed Report for Fiscal Year 2015-16 at the amounts listed. The Director of Finance and Administrative Services is hereby authorized and directed to file the Special Assessment roll with the Auditor of the County of Sacramento.
- 4) This Resolution shall take effect immediately upon adoption.




