**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT #7 TO
CONTRACT C-11-449 WITH HTA SCIENCE & ENGINEERING, INC. UPDATING THE
SCOPE OF WORK AND INCREASING THE CONTRACT NOT-TO-EXCEED AMOUNT
FROM \$60,000 TO \$81,000 FOR ENVIRONMENTAL STUDIES AND CONSULTING
SERVICES**

WHEREAS, the Elk Grove Police Department processes many types of biological and pharmacological material as a part of its investigative procedures; and

WHEREAS, these materials have the potential to cause adverse effects to personnel; and

WHEREAS, the Police Department seeks to reduce or eliminate human exposure to certain biological and pharmacological materials, yet maintain vital evidence; and

WHEREAS, the City of Elk Grove has contracted with HTA Science & Engineering, Inc. to provide studies and solutions for improving environmental quality in a law enforcement setting; and

WHEREAS, the contract between the City and HTA Science & Engineering, Inc. requires an amendment to address necessary changes in the original scope of work and an increased project budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute Amendment #7 to Contract C-11-449 with HTA Science & Engineering, Inc. updating the scope of work and increasing the contract not-to-exceed amount from \$60,000 to \$81,000 for environmental studies and consulting services.


