

RESOLUTION NO. 2015-165

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE 1) AMENDMENT NO. 2 TO CONTRACT #C-11-370 WITH VCA ANIMAL HOSPITALS IN THE AMOUNT OF \$45,000; AND 2) AMENDMENT NO. 2 TO CONTRACT #C-11-400 WITH KITTEL FAMILY VETERINARY PRACTICE IN THE AMOUNT OF \$45,000 FOR ANIMALS UNDER THE CARE OF ANIMAL CONTROL SERVICES. EACH CONTRACT SHALL HAVE A NOT-TO-EXCEED AMOUNT OF \$85,000

WHEREAS, the City of Elk Grove provides the community Animal Control Services for lost and stray animals to ensure the safety and well-being of animals and people; and

WHEREAS, the City contracts with local veterinary hospitals to provide a variety of health services to lost, injured, or sick animals found roaming the City; and


WHEREAS, in April, the City conducted a formal Request for Proposals (RFP) process seeking qualified veterinary care providers at the most competitive rates; and

WHEREAS, the City only received responses to its Animal Control Veterinary Care RFP from the current contract providers; and

WHEREAS, the two current contract providers, VCA Hospitals and Kittel Family Veterinary Practice have a history of providing the City with good service and animal care.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute 1) Amendment No. 2 to contract #C-11-370 with VCA Animal Hospitals in the amount of \$45,000; and 2) Amendment No. 2 to contract #C-11-400 with Kittel Family Veterinary Practice in the amount of \$45,000 for animals under the care of Animal Control Services. Each contract shall have a not-to-exceed amount of \$85,000 through September 30, 2018.




