

RESOLUTION NO. 2016-049

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE 2015 CITYWIDE CURB RAMP IMPROVEMENTS PROJECT  
(WAC010) AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE  
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE  
SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on July 22, 2015 the City Council authorized the award of a construction contract to C&C Construction, Inc. for the 2015 Citywide Curb Ramp Improvements Project (Capital Improvement Project ID WAC010) (the "Project"); and

**WHEREAS**, the Project removed accessibility barriers by constructing or reconstructing curb ramps, sidewalks, curb and gutter to meet current ADA accessibility requirements at various locations throughout the City; and

**WHEREAS**, C&C Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to C&C Construction, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the 2015 Citywide Curb Ramp Improvements Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




